1. Apologies and Welcome

Apologies were noted.

Dr Julie Cullen welcomed everyone to the meeting and reminded those present that although the meeting was being held in public, it was not a public meeting and therefore no participation from members of the audience would be allowed during the formal business of the Committee.

Dr Julie Cullen reminded members that the CCG undertakes primary care cocommissioning under delegated powers from NHS England. As a GP membership organisation we are open and transparent in how we handle real, perceived or potential conflicts of interest in all aspects of our business. In line with our policies the chairing of the Committee is a lay member representative. Where members or attendees are felt to have a conflict of interest, the Chair will determine whether the level of conflict excludes the member from any and all discussions. Where a decision is required, members with a declared conflict will not be permitted to vote.

The Clinical Executive lead for primary care, Dr Linda Collie, will be allowed to participate in discussions for such items unless they are directly about her practice.

2. Declarations of Interest

Dr Linda Collie, Dr Jonathan Lake and Dr Annie Eggins declared a potential conflict for Agenda Item 7 (Multispeciality Community Provider Progress Report). It was agreed that all three would be included in discussions but would be excluded for any decision making for this item.

3. Minutes of Previous Meeting

The minutes of the Primary Care Commissioning Committee meeting held on Wednesday 20 September 2017 were approved as an accurate record.

4. Primary Care Risk Register

Mark Compton and Terri Russell presented highlights of significant/key risks on the Primary Care Risk Register overseen by the Primary Care Operational Group (PCOG). Actions have been identified and are being taken to mitigate these risks.

Following a query by Jo York with regards to winter pressures, Terri Russell confirmed that this and a number of other risks are held on the overall risk register.

Dr Jonathan Lake asked how a 'likelihood' score is assigned. Mark Compton confirmed that this score is reached through discussion at PCOG however members noted that all risk scoring is subjective and is liable to change.

Jackie Powell reported that anecdotal evidence suggests that following practice mergers, patients are experiencing difficulty in booking appointments and questioned whether that had been considered a risk. Terri Russell confirmed that the merger process should ensure risks such as those are addressed by practices.

The Primary Care Commissioning Committee noted the risks and mitigation actions.

5. Scheme of Delegation

Justina Jeffs reported that following the retirement of the Director of Primary Care in June 2017, the Primary Care Scheme of Delegation has been reviewed and updated.

This has been undertaken in conjunction with the roles and responsibilities held by the Deputy Director of Primary Care, and against such schemes held by other CCGs.

The Primary Care Commissioning Committee approved the Primary Care Scheme of Delegation.

6. Finance Report

Terri Russell reported that Portsmouth CCG assumed responsibility for co-commissioning Primary Medical Care Services from the 1 April 2015. As part of the delegation from NHS England, the budget was transferred to the CCG to support the co-commissioning agenda.

Portsmouth CCG manages the primary care budget as a whole and therefore do not 'split' out the co-commissioning monies separately. This enables the CCG to retain a complete view on primary care spend, allocation, savings and investment.

The Committee has previously received a finance summary as part of the Delegated Co-Commissioning Primary Care Annual Report submission to NHS England. However, following a review of its Terms of Reference, and in keeping with good governance practice, it was proposed that the Committee has the opportunity to review the budget mid-year.

Terri Russell presented a report that highlighted year end details and forecast position. The Committee were asked to note that this did not include the prescribing position, Out of Hours Contract or the Acute Visiting Service as these are reported elsewhere.

Key points

- The total delegated budget is £26,408,792, the majority of which is contractually committed expenditure
- The CCG is currently forecasting a slight overachievement against the total primary care budget
- New expenditure in 2017/18 has had an impact on the overall budget position, including GP indemnity, CQC reimbursement, TARGET costs and the Life Channel
- Risks have been identified in relation to NHS Property Services and rent reviews which is likely to result in an underspend for the CCG.
- The CCG is forecasting full commitment of the General Practice Forward View requirements.

The Primary Care Commissioning Committee received and expressed support for the report.

7. Multispeciality Community Provider (MCP) Progress Report

All GP and Practice Members of the Committee have a direct conflict of interest in this item. No decision is required at this time by the Committee and therefore the Chair agreed that these members could remain and participate in the general discussion.

Mark Compton spoke to this item. The report provided an update to the Committee on the progress of the MCP since their meeting in September 2017.

Mark Compton stated that NHS England have expressed confidence in our progress to date:

- The MCP working group held a 'Road Mapping' workshop with members from NHS England's national New Business Models team the New Care Models team to discuss national MCP developments.
- The MCP working group has identified a need to undertake a thorough options appraisal in relation to potential procurement options of an MCP contract. A complementary Strategic Case for Change document will also be developed to assist in this decision making process. Mark Compton and Jo York will provide an MCP procurement options appraisal at the next Committee meeting.

Action: M Compton

- The working group responded to the Department of Health national consultation on the Accountable Care Organisation (ACO) Contract. The ACO is an umbrella term for integration of primary, community and Primary and Acute Care Systems. Dr Julie Cullen reported that the language is changing nationally, and we may see some dominant ACO language in the future, however, concluded that the MCP will not need to change. Jackie Powell commented that language should be clear and meaningful to other groups and that working better together through partnership working and partnership health is fundamental.
- The CCG and Healthwatch Portsmouth have been working in partnership to agree priority public and patient engagement activities in relation to the MCP programme, along with Phase 2 of Your Big Health Conversation. Specific patient groups including evaluating services have been shared through transformation projects and Healthwatch, although patient choice has been limited.
- The Working Group has been established and is meeting regularly to deliver the agreed priority activities; and sharing transformation projects with Healthwatch and doing work with specific patient groups, including evaluating services.

The Primary Care Commissioning Committee noted the context of the report and expressed support of the MCP development programme.
